#### **Section 4: First Aid Measures**

## Necessary first aid measures

Penicillins and cephalosporins may cause hypersensitivity (allergy) following injection, inhalation, ingestion or skin contact. Do not handle this product if you know you are sensitised, or if you have been advised not to work with such preparations. Handle this product with great care to avoid exposure.

**ACCIDENTAL SELF-INJECTION** Obtain medical attention - show this SDS. Accidental self-injection may lead to an inflammatory response and medical advice should be sought on the management of deep injections, particularly those near a joint or associated with bruising. If possible the application of gentle squeezing pressure with absorbent material (e.g. facial tissues) at the injection site will swab up unabsorbed vaccine. Strong squeezing of the site should be avoided. The damaged area should be thoroughly cleansed and a topical antiseptic applied.

**SKIN CONTACT** While wearing protective gloves, carefully remove any contaminated clothing, including shoes, and wash skin thoroughly with soap and water. If irritation or symptoms occur or persist, consult a doctor.

**EYE CONTACT** Immediately rinse eyes thoroughly with plenty of water. If wearing contact lenses, remove only after initial rinse, and continue rinsing eyes for at least 15 minutes. If irritation occurs or persists, consult a doctor.

**INGESTION** Rinse mouth and drink a glass of water. Do not induce vomiting unless under the direction of a qualified medical professional or National Poisons Centre. If symptoms persist, consult a doctor.

**INHALATION** Remove to fresh air and provide oxygen if necessary. If any trouble breathing, get immediate medical attention. Administer artificial respiration if breathing has ceased. If irritation or symptoms occur or persist. consult a doctor.

**Notes for medical** personnel

Cefquinome is a cephalosporin with bactericidal activity. Cephalosporins may cause hypersensitivity reactions including anaphylaxis, skin rashes, fever, or skin rashes in susceptible individuals. Contact dermatitis developed in nurses exposed to a similar cephalosporin, and another cephalosporin may have cause a photosensitization reaction.

Ingestion of cephalosporins may produce gastrointestinal effects including nausea, vomiting, or diarrhoea. Other effects that may occur include headache, confusion, restlessness, agitation, ringing in the ears, muscle incoordination, double vision, decreased white blood cells, platelets, and red blood cell counts, or kidney effects.

Accidental self-injection: Treat symptomatically. Some risk of hypersensitivity from injection. Contamination of the needle must be considered.
